The Screw Barrier Strip Assembly provides interconnection to one VRC DB-37 male connector. A VRC Metering, Status or Command input/output connector can be accommodated by this pre-wired Screws Barrier Assembly. A four-foot interconnection cable containing a female DB-37 connector is attached.

Pin-out to screw numbers (top or bottom) are shown on the facing page of this Instruction Sheet.

The unit is rack mounted in a standard 19" rack.
